| Mayor and Council Reports | Council Member McCusker spoke regarding several concerns: Slow progress on the Highway 19 crossing. High level of truck traffic in a residential area where fill was being removed from the top of the hill. Challenges the pool committee will face. Appreciation for Officer Ayres' years of service and congratulations on promotion of Officer Colvard Cannon Valley Rental closing; request that businesses come to the Economic Development Authority when they are facing difficulties. |

Council Member Holst invited residents who were having problems with Mediacom to attend the October 22nd Cable Commission meeting. Those who would be unable to attend were encouraged to contact a council member with their concerns.

Council Member Holst requested that the 30 mph speed limit on County Road 17 be extended to the city limit. Police Chief McCormick explained that the city is not authorized to change the speed limit on a county road but the request could be made to the county, which was conducting traffic surveys to determine speeds on several roads.
