### RESOLUTION REGARDING TITLE REGISTRATION

**WHEREAS,** the City has been served with a Summons In the Matter of the Application of Carolee A. Stock ("Owner") to register the title to property ("Summons") located in the City of Cannon Falls legally described in Exhibit A and depicted in Exhibit B attached hereto ("Property");

**WHEREAS**, the Property is in an area of the City that was developed over a hundred years ago and has numerous title issues from erroneous legal descriptions which inhibit the sale and issuance of title insurance for the Property;

**WHEREAS**, the Owner is attempting to clear title to the Property and to reflect a legal description to the Property that is consistent with the long-term use of the Property;

**WHEREAS,** the City purchased a portion of the Property in connection with its acquisition of the larger Minnesota Malting Company property site; however, based on a review of the historical use of the Property, the Owner appears to have a legitimate claim to ownership of that portion through adverse possession;

**WHEREAS,** the City has an interest in portions of the Property that include the platted right of ways for Ohio Street and Seventh Street ("Platted ROWs");

**WHEREAS**, the City has no plan to use the Platted ROWs in the future;

**WHEREAS**, the City Council believes it is in the best interest of the City for the Owner to establish clear title to the Property and to establish a proper legal description for the Property consistent with its historical use;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CANNON FALLS, GOODHUE COUNTY, MINNESOTA, that the City will take no action to answer or object to the Summons in the title registration proceeding for the Property.
