**AN ORDINANCE AMENDING CHAPTER 152 OF THE  
CANNON FALLS CITY CODE BY REZONING CERTAIN  
PROPERTY FROM A R-3, MEDIUM DENSITY RESIDENTIAL DISTRICT TO AN I-1,  
LIMITED INDUSTRIAL DISTRICT**

THE CITY COUNCIL OF CANNON FALLS ORDAINS:

**Section 1.** That property described as PID's 52.100.0040, 52.100.0050 and 52.100.0060 and identified by map in Exhibit A are hereby changed in zoning from a R-3, Medium Density Residential District to an I-1, Limited Industrial District.

**Section 2.** The Zoning Map of the City of Cannon Falls referred to and described in Chapter 152, shall be updated to reflect revisions to the Ordinance.

**Section 3.** This Ordinance shall be effective immediately upon its passage and publication.

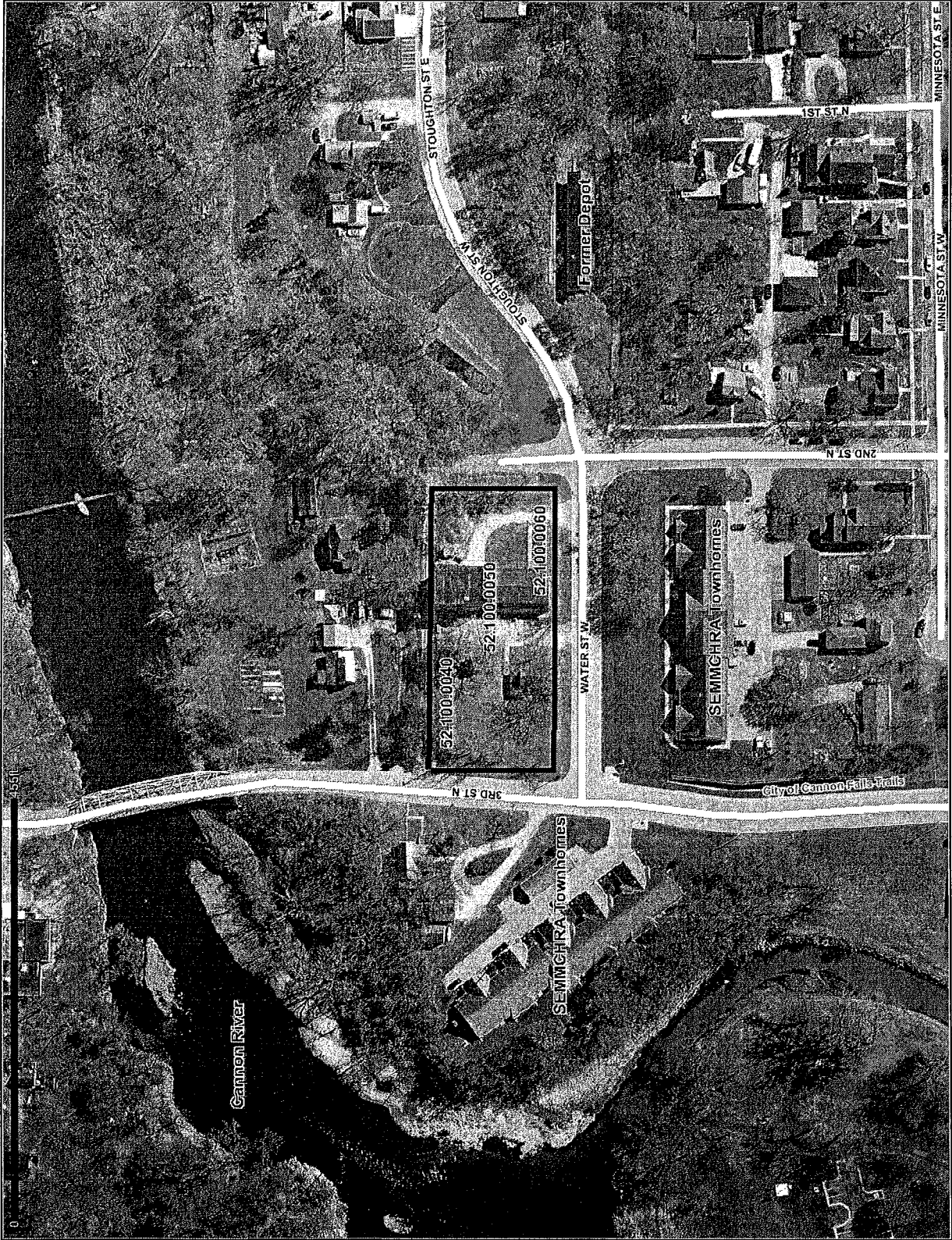
