# A RESOLUTION ORDERING FEASIBILITY REPORT FOR THE WEST SIDE II STREET IMPROVEMENT PROJECT

WHEREAS, it is proposed to improve Hoffman Street West between the center line of Dow Street North and the center line of 6th Street North; Mill Street West between the center line of Dow Street North and the center line of 7th Street North; Park Street West between its terminus west of Floyd Street South and the center line of 8th Street South; Floyd Street between the center line of Park Street West and the center line of Hoffman Street West; York Street North between the center line of Main Street West and the center line of Hoffman Street West; 9th Street South between 200 feet south of the center line of Mill Street West and the center line of Hoffman Street West; 8th Street South between 200 feet south of the center line of Park Street West and the center line of Mill Street West and the center line of Mill Street West and the center line of Mill Street West and the center line of Hoffman Street West and 7th Street North between the center line of Mill Street West and 200 feet north of the center line of Hoffman Street West by the construction of streets, sidewalks, storm sewers, sanitary sewers, water mains and service lines and to assess the benefited property for all or a portion of the cost of the improvement, pursuant to Minnesota Statutes, Chapter 429;

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CANNON FALLS, MINNESOTA:

That the proposed improvement, called West Side II Street Improvement Project be referred to Short Elliott Hendrickson Inc. for study and that that person is instructed to report to the council with all convenient speed advising the council in a preliminary way as to whether the proposed improvement is necessary, cost-effective, and feasible; whether it should best be made as proposed or in connection with some other improvement; the estimated cost of the improvement as recommended; and a description of the methodology used to calculate individual assessments for affected parcels.
