## **BACKGROUND**

With the Highway 52 project we renamed roads on the east side of the highway. As part of this project we meet with Goodhue County on September 5, 2014 regarding street signs. During that meeting Goodhue County requested that the street name for two roads on the west side be changed. Before the project 318<sup>th</sup> St. Way and 320<sup>th</sup> St. Way were dead-end roads. With the project a new road was created to the west and both were extended to the new road, 63<sup>rd</sup> Ave. Since these are no a longer dead-end road, the use of the term "Way" no longer applies because it now is a through street.

I have prepared an Ordinance based off the one created for the renaming from April and have attached map exhibits of the streets to be renamed

Once the Ordinance has been approved and is effective I will be working with the Post Office, Goodhue County Assessor and Public Works to implement the renaming of the streets. Then letters will be sent to business and property owners within the City informing them of the new street name.


