SUBJECT: CANVASS AND DECLARE ELECTION RESULTS

BACKGROUND

The City of Cannon Falls held the City General Election on November 4, 2014 for the offices of Mayor, two 4-year Council Members and one 2-year Council Member. Minnesota State Statute requires the City Council to act as the Canvassing Board to canvass the returns and declare the election results within three to ten days after the election. Goodhue County provided an Abstract of Votes Cast in the Precincts of the City of Cannon Falls compiling the results from the official returns. The results are indicated in the proposed resolution. Once the results are adopted, the Council will sign the abstract as the Canvassing Board.

STAFF RECOMMENDATION

Staff recommends the Council approve the Resolution canvassing and declaring the election results and sign the Abstract of Votes Cast.
