CITY OF CANNON FALLS, MINNESOTA CABLE FRANCHISE APPLICATION INSTRUCTIONS

Applicants for a cable franchise must submit the following information to the City on or before 4:00 p.m., August 29, 2016. Submission of this information will constitute application for a cable franchise.

(1) Plans for channel capacity, including both the total number of channels capable of being delivered and actually to be delivered upon system activation;

With a fiber to the home network there are no limitations on the number of channels to be activated in the system. Initially HBC plans to activate 135 standard definition channels; 89 high definition channels; 45 digital music channels, 44 premium channels, along with video on demand.

(2) A statement of the television and radio broadcast signals for which permission to carry has been obtained or will be requested from the Federal Communications Commission;

Exhibit A is the proposed channel lineup. HBC will file its new community registration application with the FCC prior to launch of video services in Cannon Falls.

(3) In the case of a telephone provider, a copy of the MPUC certificate of authority;

- (4) A description of the proposed system design and planned operations, including at least the following items:
 - a. the location of the headend facilities from which programming will be received;

HBC currently operates a cable television, telephone and data network in Winona, with a main operations center at 58 Johnson Street and backup facilities at 111 Riverfront in Winona. HBC will use these facilities to source television content, Internet bandwidth and telephone connectivity.

b. an explanation of the ownership of the facilities comprising the video system;

HBC is a privately held company.

c. a map identifying the proposed initial service area(s) in the City;

The service area will be the currently zoned city limits of Cannon Falls. See attached map provided as Exhibit C.

d. a proposed schedule for expansion of service beyond the initial service area or description of the proposed policy for such expansion;

HBC reviews all requests for new service expansion outside of the initial service area (city

limits). Typically we begin expanding outside city limits once the initial service area is completed.

e. the schedule for activating two-way capacity; i.e. capacity to send video signals "up stream";

The network will be an IP, fiber optic network. Two-way capacity will be available day one.

f. the number of channels and services to be made available for community access broadcasting, and a proposal for providing community access programming;

HBC 20 is a local programming channel that will be included for Cannon Falls residents who may submit message board items as well as programs digitally, via the Internet. There is no charge for this service for community groups, churches, schools and other not-for-profit organizations.

HBC will provide Cannon Falls residents with a strong selection of local video programming that is available within the company's basic cable lineup on HBC's branded channel, HBC TV-25. This local channel will feature sports, feature stories and educational programs, cultural events and community attractions such as parades and pageants, interactive issue-oriented community discussions, cultural and more.

g. a general description of any non-video services such as telephone service, high speed internet or data transmission services to be provided in the City.

HBC will provide up to gigabit Internet speeds as well as local and long distance telephone services including a number of calling features.

(5) A proposal for funding community access programming facilities and/or staff;

HBC intends to pay the proposed franchise fee and meet all additional terms in the Franchise Agreement. HBC will also be bringing its own local TV 25 channel which will cover various local events. Community access programming, equipment and facilities that are used by other providers will require costs to be shared. Other community access funding will be provided for coverage specifically on the HBC network.

(6) The terms and conditions under which services will be provided to institutions and identification of any plans for providing free or reduced price video or data transmission services or capacity or other "in-kind" services to governmental, educational, and other institutional entities;

HBC prides itself on establishing consistency in its practice across all the markets it serves. Cannon Falls will not be an exception.

HBC will supply all governmental and educational entities with free cable television services as programming contractual agreements allow.

(7) A schedule of proposed service rates and the proposed policy regarding charges for unusual or difficult service connections;

The general policy of HBC is to charge the same or similar rates in each community it serves. HBC intends to charge rates comparable to those charged by the other local cable operator and other systems for similar services and installations. The actual rates will be based on analysis of costs, competitive rates, regulatory constraints, and other such factors such as franchise fees and charges.

In cases of difficult or unusual installations, HBC may charge for the incremental increase in material and labor costs incurred beyond the standard installation.

(8) A schedule for constructing and activating the system including the sequence in which video service will be activated in various parts of the City;

HBC plans to install and provide service to any person requesting service provided that said service can meet FCC technical specifications. Construction could begin as soon as November 2016. HBC already has a fiber optic network connecting to Cannon Falls and has fiber built through the middle of town. The next phase would be constructing the City of Cannon Falls with fiber to each individual resident and business. The tentative build out plan would depend on the engineering overview, which typically is the construction area closest to the entry point of backbone network into the community. Once a resident's home or business is completed, including the drop, those customers could then be installed. We would expect the first customer with video service to be activated in the first half of 2017.

(9) A statement indicating the applicant's qualifications and experience in the video services field, if any;

Created in 1993 by visionary Winona residents as a not-for-profit education project known as Luminet, Winona became one of the first small towns in the United States to have its own Internet service provider. That initiative led in 1997 to the creation of Hiawatha Broadband Communications, Inc. (HBC). HBC was created for three reasons. To: 1) continue Luminet's education mission; 2) put into place, for economic development reasons, a state-of-the-art telecommunications network; and, 3) offer choice to residents in areas served by monopoly providers.

The Winona hybrid fiber coaxial network was completed in 1999. In 2001, in response to an appeal by the St. Charles, Minnesota, Economic Development Association, HBC constructed its second and HFC network in that community 20 miles west of Winona.

Three years later, a decision was made to develop an all-fiber network in Wabasha, Minnesota. An outstanding success, with more than 70 percent penetration in the community 30 miles north of Winona, HBC in the next five years completed fiber-to-the-home networks in Lewiston, Rollingstone and Stockton, Minnesota, and during the summer of 2010 built networks in Minneiska and Utica, Minnesota, solving a number of problems there. The Minneiska network includes early-warning devices placed in each home and business in the community. In 2012, HBC expanded its fiber-to-the-home network to Dover, Eyota, Elgin, Plainview, Lake City and Red Wing.

HBC has achieved its success not only through its leading edge networks and reliable services, HBC also outperforms the competition through exemplary customer service and the production and 482998v1 RJV CA135-10

broadcast of local television events, including original community programming and local high school and college sports.

HBC has received many awards and accolades from the telecommunications industry, including a salute from the FCC for its service to the team preparing the National Broadband Plan, the Broadband Properties magazine's prestigious Cornerstone Award and the Fiber to the Home Council's 2010 Chairman's award for exemplary service to the industry.

HBC has also been hailed as a good corporate citizen by each of its markets for exemplary community involvement, including numerous volunteer activities, and company contributions to civic activities and not-for-profit organizations.

(10) Identification of and contact information for the municipalities in which the applicant either owns or operates a video system, directly or indirectly, or holds video franchises;

HBC serves nine communities in Winona County, Minnesota; five in Wabasha County, Minnesota; one in Goodhue County, Minnesota; and two in Olmstead County, Minnesota.

The company holds franchise agreements in all of the markets listed below, with the exception of Homer, Minnesota City and Reads Landing, which are served through line extension agreements with Winona (in the case of Homer and Minnesota City) and Wabasha (in the case of Reads Landing).

- (14) An application fee totaling \$7,500.00 to offset the City's costs associated with processing applications. Any portion of the application fee which remains after payment of all the City's costs will be refunded.

All applications must be notarized and must include detailed responses to the above.

Negotiation of Franchise Terms. The City expects to discuss and negotiate franchise terms and conditions with a successful applicant. The City reserves the right to seek franchise terms and conditions or other commitments that meet or exceed the plans contemplated in an application.

Additional Information. The City may request such additional information as it deems necessary. In determining whether to issue a franchise, the City will consider the application and additional relevant information. Additional factors the City may consider include the qualifications of applicant(s), the level and quality and nature of services proposed by the applicant, the needs and interests of the community and institutions as identified by the City, and information regarding industry trends, state of the art technologies, services and other related information.

<u>Public Hearing on Applications</u>. A public hearing with respect to application(s) will be scheduled at least seven days before the City Council considers adoption of a franchise ordinance. The hearing will afford the public and franchise applicant(s) reasonable notice and a reasonable opportunity to be heard.

<u>Existing Franchise</u>. Applicants are advised that Mediacom Minnesota currently provides cable television service in the City pursuant to an expired cable franchise. The City and Mediacom are engaged in renewal negotiations. The City reserves the right to impose additional or more burdensome terms and conditions in any franchises adopted as a result of this application process.

Award of Franchise. A franchise may, in the City's sole discretion, be awarded by ordinance.

Before becoming operational in the Cannon Falls and Goodhue exchanges, Hiawatha Broadband Communications, Inc. must file any necessary updates to its 911 plan and must file and receive Commission approval of interconnection agreements with the underlying carriers (i.e., Citizens Telecommunications Company of Minnesota, LLC and Sleepy Eye Telephone Company) serving each of the two affected exchanges.

Approved the updated tariff pages included with the petition.

This decision is issued by the Commission's consent calendar subcommittee, under a delegation of authority granted under Minn. Stat. § 216A.03, subd. 8 (a). Unless a party, a participant, or a Commissioner files an objection to this decision within ten days of receiving it, it will become the Order of the full Commission under Minn. Stat. § 216A.03, subd. 8 (b).



CITY OF CANNON FALLS, MINNESOTA CABLE FRANCHISE APPLICATION INSTRUCTIONS

Applicants for a cable franchise must submit the following information to the City on or before 4:00 p.m., August 29, 2016. Submission of this information will constitute application for a cable franchise.

(1) Plans for channel capacity, including both the total number of channels capable of being delivered and actually to be delivered upon system activation;

With a fiber to the home network there are no limitations on the number of channels to be activated in the system. Initially HBC plans to activate 135 standard definition channels; 89 high definition channels; 45 digital music channels, 44 premium channels, along with video on demand.

(2) A statement of the television and radio broadcast signals for which permission to carry has been obtained or will be requested from the Federal Communications Commission;

Exhibit A is the proposed channel lineup. HBC will file its new community registration application with the FCC prior to launch of video services in Cannon Falls.

(3) In the case of a telephone provider, a copy of the MPUC certificate of authority;

- (4) A description of the proposed system design and planned operations, including at least the following items:
 - a. the location of the headend facilities from which programming will be received;

HBC currently operates a cable television, telephone and data network in Winona, with a main operations center at 58 Johnson Street and backup facilities at 111 Riverfront in Winona. HBC will use these facilities to source television content, Internet bandwidth and telephone connectivity.

b. an explanation of the ownership of the facilities comprising the video system;

HBC is a privately held company.

c. a map identifying the proposed initial service area(s) in the City;

The service area will be the currently zoned city limits of Cannon Falls. See attached map provided as Exhibit C.

d. a proposed schedule for expansion of service beyond the initial service area or description of the proposed policy for such expansion;

HBC reviews all requests for new service expansion outside of the initial service area (city

limits). Typically we begin expanding outside city limits once the initial service area is completed.

e. the schedule for activating two-way capacity; i.e. capacity to send video signals "up stream";

The network will be an IP, fiber optic network. Two-way capacity will be available day one.

f. the number of channels and services to be made available for community access broadcasting, and a proposal for providing community access programming;

HBC 20 is a local programming channel that will be included for Cannon Falls residents who may submit message board items as well as programs digitally, via the Internet. There is no charge for this service for community groups, churches, schools and other not-for-profit organizations.

HBC will provide Cannon Falls residents with a strong selection of local video programming that is available within the company's basic cable lineup on HBC's branded channel, HBC TV-25. This local channel will feature sports, feature stories and educational programs, cultural events and community attractions such as parades and pageants, interactive issue-oriented community discussions, cultural and more.

g. a general description of any non-video services such as telephone service, high speed internet or data transmission services to be provided in the City.

HBC will provide up to gigabit Internet speeds as well as local and long distance telephone services including a number of calling features.

A proposal for funding community access programming facilities and/or staff;

HBC intends to pay the proposed franchise fee and meet all additional terms in the Franchise Agreement. HBC will also be bringing its own local TV 25 channel which will cover various local events. Community access programming, equipment and facilities that are used by other providers will require costs to be shared. Other community access funding will be provided for coverage specifically on the HBC network.

(6) The terms and conditions under which services will be provided to institutions and identification of any plans for providing free or reduced price video or data transmission services or capacity or other "in-kind" services to governmental, educational, and other institutional entities;

HBC prides itself on establishing consistency in its practice across all the markets it serves. Cannon Falls will not be an exception.

HBC will supply all governmental and educational entities with free cable television services as programming contractual agreements allow.

(7) A schedule of proposed service rates and the proposed policy regarding charges for unusual or difficult service connections;

The general policy of HBC is to charge the same or similar rates in each community it serves. HBC intends to charge rates comparable to those charged by the other local cable operator and other systems for similar services and installations. The actual rates will be based on analysis of costs, competitive rates, regulatory constraints, and other such factors such as franchise fees and charges.

In cases of difficult or unusual installations, HBC may charge for the incremental increase in material and labor costs incurred beyond the standard installation.

(8) A schedule for constructing and activating the system including the sequence in which video service will be activated in various parts of the City;

HBC plans to install and provide service to any person requesting service provided that said service can meet FCC technical specifications. Construction could begin as soon as November 2016. HBC already has a fiber optic network connecting to Cannon Falls and has fiber built through the middle of town. The next phase would be constructing the City of Cannon Falls with fiber to each individual resident and business. The tentative build out plan would depend on the engineering overview, which typically is the construction area closest to the entry point of backbone network into the community. Once a resident's home or business is completed, including the drop, those customers could then be installed. We would expect the first customer with video service to be activated in the first half of 2017.

(9) A statement indicating the applicant's qualifications and experience in the video services field, if any;

Created in 1993 by visionary Winona residents as a not-for-profit education project known as Luminet, Winona became one of the first small towns in the United States to have its own Internet service provider. That initiative led in 1997 to the creation of Hiawatha Broadband Communications, Inc. (HBC). HBC was created for three reasons. To: 1) continue Luminet's education mission; 2) put into place, for economic development reasons, a state-of-the-art telecommunications network; and, 3) offer choice to residents in areas served by monopoly providers.

The Winona hybrid fiber coaxial network was completed in 1999. In 2001, in response to an appeal by the St. Charles, Minnesota, Economic Development Association, HBC constructed its second and HFC network in that community 20 miles west of Winona.

Three years later, a decision was made to develop an all-fiber network in Wabasha, Minnesota. An outstanding success, with more than 70 percent penetration in the community 30 miles north of Winona, HBC in the next five years completed fiber-to-the-home networks in Lewiston, Rollingstone and Stockton, Minnesota, and during the summer of 2010 built networks in Minneiska and Utica, Minnesota, solving a number of problems there. The Minneiska network includes early-warning devices placed in each home and business in the community. In 2012, HBC expanded its fiber-to-the-home network to Dover, Eyota, Elgin, Plainview, Lake City and Red Wing.

HBC has achieved its success not only through its leading edge networks and reliable services, HBC also outperforms the competition through exemplary customer service and the production and 482998v1 RJV CA135-10

broadcast of local television events, including original community programming and local high school and college sports.

HBC has received many awards and accolades from the telecommunications industry, including a salute from the FCC for its service to the team preparing the National Broadband Plan, the Broadband Properties magazine's prestigious Cornerstone Award and the Fiber to the Home Council's 2010 Chairman's award for exemplary service to the industry.

HBC has also been hailed as a good corporate citizen by each of its markets for exemplary community involvement, including numerous volunteer activities, and company contributions to civic activities and not-for-profit organizations.

(10) Identification of and contact information for the municipalities in which the applicant either owns or operates a video system, directly or indirectly, or holds video franchises;

HBC serves nine communities in Winona County, Minnesota; five in Wabasha County, Minnesota; one in Goodhue County, Minnesota; and two in Olmstead County, Minnesota.

The company holds franchise agreements in all of the markets listed below, with the exception of Homer, Minnesota City and Reads Landing, which are served through line extension agreements with Winona (in the case of Homer and Minnesota City) and Wabasha (in the case of Reads Landing).
