### **BACKGROUND**

At the August 16, 2016 meeting, City Council approved a motion requesting that Goodhue County withhold the sale of tax-forfeited parcel 52.456.0090 for six-months to allow for continued planning within the Sandstone Ridge subdivision. Goodhue County has since requested that Council approve this by resolution.

The following is a summary of information in the last meeting packet related to this: Southeast MN Multi-County Housing and Redevelopment Authority (SEMMCHRA) continues to look into the potential development of Sandstone Ridge.

Their staff met with county and city staff on August 10 to review a feasibility report of redeveloping Sandstone Ridge prepared for SEMMCHRA by Stantec Consulting Services.

During this meeting, I shared this letter from Goodhue County informing that another parcel in the Sandstone Ridge Subdivision was forfeited to the State of MN for non-payment of taxes. We discussed the importance of maintaining control of this parcel while planning is being conducted. It was agreed that it could be harmful to any potential project in this area if this parcel/outlot was purchased by a private party.

The main storm sewer and sewer main into the Sandstone subdivision extend through this parcel.

#### REQUESTED COUNCIL ACTION

Approve a motion adopting a Resolution Requesting that Goodhue County Withhold the Sale of Tax-Forfeited Parcel 52.456.0090 for six-months to allow for continued planning within the Sandstone Ridge subdivision.
