Dear Dave:

We appreciate the opportunity to provide professional services to the City for final design, plan preparation and bidding services for the construction of an access road off of 63rd Avenue to serve the proposed hotel site and Southview Acres. This letter serves as our understanding of the project scope and schedule. Our scope of work includes the following tasks:

- Review the existing topographic survey information and gather additional survey if needed.
- Final design of the access road (anticipated to be a 32-foot wide, urban section road ending in a cul-de-sac).
- Prepare construction plans and specifications to City standards per the improvements identified above and with City staff input.
- Coordinate with private utilities to identify conflicts with the proposed improvements.
- Coordinate with MnDOT and Goodhue County on approval for the new road connection to 63rd Avenue.
- Review the construction plans with City staff prior to bidding.
- Assist the City in the advertisement of the project for bids, attend the bid opening, tabulate
 the bids and provide a recommendation of award.

SEH proposes to complete the above tasks for a fee of \$16,800 and be compensated on an hourly basis. Compensation will be based on the hourly cost of personnel plus reimbursable expenses, including reproductions, mileage and equipment. Upon approval of this proposal, SEH will within 4 weeks present the City with preliminary construction plans along with a preliminary cost estimate of the improvements for staff review and comment. Upon receiving comments from the City, SEH will incorporate comments, finalize the bidding documents and present them to the City for approval to advertise for bids by February 1, 2017. If there are delays beyond our control, the City agrees to grant additional time to complete the services.
