**A RESOLUTION DESIGNATING THE DEPOSITORIES FOR CITY FUNDS FOR  
FISCAL YEAR 2017**

**WHEREAS**, the Cannon Falls City Charter states that the Council must annually designate depositories for City funds in accordance with law; and

**WHEREAS**, the Cannon Falls City Charter further states that a depository must be located within the United States; and

**WHEREAS**, the Cannon Falls City Charter further states that a depository must be located within the boundaries of the City unless the Council determines by resolution that designation of a depository located outside the boundaries of the City is required to serve the City's best interest; and

**WHEREAS**, Minnesota Statute 427.01 requires the City Council to designate official depositories for city funds at its first meeting of the new fiscal year via resolution.
