BACKGROUND

Fire Chief Anderson will be present to discuss the Fire Department's request to purchase a new truck.

Attached is info from the proposed truck provider, Custom Fire.

If approved, the likely funding tool for the purchase is equipment certificates. I'm attaching a potential payment schedule from George Eilertson, Northland Securities, for the issuance of equipment certificates with scenarios of a 5 year, 8 year or a 10 year payment schedule. There is approximately \$190,000 in the Fire Dept Capital Fund. The payment schedule shows the utilization of \$100,000 of these funds and another scenario utilizing \$150,000.

Honorable Cannon Falls Mayor and City Council,

I have been asked to supply you with information on the new Rescue Truck and why the need of the purchase. I will come prepared to discuss the need of this new truck at the July 19, 2017 council meeting.

The Cannon Falls Fire Department currently has a 1996 International Rescue Truck. It has 20,356 miles and 2,140 hours of running time. It also has a 16 foot box, that houses a command center. The most important part of the truck is that it carries all of our tools for extrication at vehicle accidents and equipment needed to assist in all rescue situations.

Why the need for a new rescue truck? It is 21 years old and as a department, it was scheduled to be replaced at 20 years. The specs on the new truck would last for 20 years into the future. If we were to look at used vehicles, we would only be putting a bandaid on the situation. It will run into a situation where the City would need to replace 2 vehicles in one year.

The biggest problem with the current truck is the storage for all of the equipment, please see attached sheet for the list of equipment. By getting rid of the command center, we can use this space to put sliding drawers and pass through compartments to better store and organize our current equipment. The way it is now, we have equipment in multiple locations. To be able to access equipment quickly, it should be organized in central locations.

Will his truck last a few more years? The truck has been serviced annually. On the way to two fire and rescue calls, the rescue truck has been broken down on the side of the road. A reliable truck is needed.

Thank you for the consideration of a new Cannon Falls Fire Department Rescue Truck. I will have Custom, the manufacturer the department has chosen for the truck, attending the council meeting to answer any questions you may have.
