**A RESOLUTION TO ESTABLISH LICENSE FEES FOR BREWER TAPROOMS**

**WHEREAS**, the Cannon Falls City Code provides that fees for licenses and compensation not specifically set by the Code, shall be fixed and determined by resolution of the City Council, and

**WHEREAS**, the City Council amended Chapter 111 of the Cannon Falls City code to include Brewer Taproom On-Sale and Off-Sale licenses.

**NOW, THEREFORE BE IT RESOLVED**, that the following license fees shall be established effective on or after November 7, 2017:

Brewer Taproom On-Sale License	\$400.00
Brewer Taproom Off-Sale License	\$100.00

**ORDINANCE NUMBER 344  
SECOND SERIES**

**AN ORDINANCE AMENDING CHAPTER 111  
OF THE CANNON FALLS CITY CODE CONCERNING  
ALCOHOL LICENSING AND REGULATION**

THE CITY COUNCIL OF CANNON FALLS ORDAINS:

**Section 1.** Section 111.001 of the Cannon Falls City Code is hereby amended to include the following definition:

**BREWER.** A person who manufactures malt liquor for sale and is licensed under Minnesota Statute 340A.301, subdivision 6, clause (c), (i), or (j).

**Section 2.** Chapter 111 of the Cannon Falls City Code is amended by adding a new Section Title “**Brew Licensing**” and it shall be placed between the section title of Beer Licensing and Liquor Licenses, and the first number of the Brew Licensing section shall be 111.080.

**Section 3.** Chapter 111 of the Cannon Falls City Code is amended by renumbering section 111.091 to 111.080:

**Section 4.** Chapter 111 of the Cannon Falls City Code is amended by adding section 111.081 to provide as follows:

Brewer Taproom On-sale License. A brewer taproom On-sale License authorizes on-sale of malt liquor produced by the brewer for consumption on the premises of or adjacent to one brewery location owned by the brewer.

**Section 5.** Chapter 111 of the Cannon Falls City Code is amended by adding section 111.082 to provide as follows:

**111.082 Hours and Days of Brewer Taproom On-sale License.** No sale of malt liquor may be made between 12:00 a.m. and 8:00 a.m. on the days of Sunday through Thursday, or before 10:00 a.m. on Sunday except that on the Wednesday before Thanksgiving and on New Year's Eve sales are permitted until 2:00 a.m. No sale of malt liquor may be made between 2:00 a.m. and 8:00 a.m. on the days of Friday and Saturday. No licensee may sell malt liquor between the hours of 1:00 a.m. and 2:00 a.m. unless the licensee has obtained a permit from the state pursuant to the provisions of M.S. § 340A.504, Subdivision 7, as it may be amended from time to time

**Section 6.** Chapter 111 of the Cannon Falls City Code is amended by adding section 111.083 to provide as follows:

**111.083 Brewer Taproom Off-sale License.** A brewery taproom Off-sale License authorizes retail off-sale of malt liquor produced by the brewer as provided by Minnesota Statute 340.28.


**Section 7.** Chapter 111 of the Cannon Falls City Code is amended by adding section 111.084 to provide as follows:

**111.084 Hours and Days of Brewer Taproom Off-sale License.** No sale of malt liquor shall be made by a Taproom Off-sale licensee before 8:00 a.m. or after 10:00 p.m. on Monday through Saturday; or before 10:00 a.m. or after 10:00 p.m. on Sunday. No sales shall be made on Thanksgiving Day; after 8:00 p.m. on Christmas Eve, December 24; or on Christmas Day, December 25.


**Section 8. Effective Date.** This ordinance shall be effective immediately upon its passage and publication according to law.
