**A RESOLUTION RECEIVING FEASIBILITY REPORT FOR THE EASTSIDE II PUBLIC
IMPROVEMENTS**

WHEREAS, pursuant to action of the Cannon Falls City Council, a feasibility report has been prepared by Short Elliott Hendrickson Inc. for the Eastside II Public Improvements that included the following proposal to improve Minnesota Street East between the center line of 2nd Street North and its east terminus; 1st Street North between the center line of Minnesota Street East and its north terminus; Cedar Street North between the center line of Minnesota Street East and its south terminus; Oak Street North between the center line of State Street East and its north terminus; Vine Street North between the center line of Minnesota Street East and the center line of State Street East; Grove Street North between the center line of Minnesota Street East and its east terminus; Almond Street East between the center line of Water Street East and the center line of State Street East; and Mill Street East between the center line of Oak Street East and its east terminus by the construction of streets, sidewalks, storm sewers, sanitary sewers, water mains and service lines and to assess the benefited property for all or a portion of the cost of the improvement, pursuant to Minnesota Statutes, Chapter 429;

Whereas, this report was received by the Council on the 19th day of December, 2017 and
