**A RESOLUTION ADOPTING PRIMARY AND GENERAL ELECTION JUDGES FOR  
2018 AND SETTING THE HOURLY WAGES**

**WHEREAS**, the City Council of the City of Cannon Falls is required by M.S. 204B.21, subd. 2, to officially approve the appointment of elections judges; and

**WHEREAS**, election judges must successfully complete training and eligibility requirements, and

**WHEREAS**, the Cannon Falls City Council hereby adopts the judges listed on Exhibit A, hereto attached, as the official judges for the August 14, 2018 Primary Election and November 6, 2018 General Election, with the understanding that substitutions may be necessary to the appointments in order to fill vacancies, and meet eligibility and party affiliation requirements; and

**WHEREAS**, the Cannon Falls City Council hereby sets the hourly wages as follows:

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Cannon Falls that the names listed on Exhibit A, hereto attached, are the official Election Judges for the City of Cannon Falls, for the August 14, 2018 Primary Election and November 6, 2018 General Election.

**BE IT FURTHER RESOLVED**, the City Council of the City of Cannon Falls, does hereby allow the Elections Administrator or City Administrator to make substitutions to the attached slate of judges as necessary to fill vacancies and to meet and maintain eligibility and party affiliation requirements.

**BE IT ALSO FURTHER RESOLVED**, the City Council of the City of Cannon Falls sets the hourly wages for the Head Judges to be \$13.20 and Election Judges to be \$10.00.
