SUBJECT: Cannon Falls Lions Mobile Food Unit

BACKGROUND

The Cannon Falls Lions requests permission to park their mobile food unit on Mill Street in front of Tilion Brewing the evening of October 4th through the evening of October 6th. They will reserve not more than two parking spaces and will designate the spaces with cones. They will be setting up two propane grills and one propane heated pot to broil bratwurst. The grill and pot will be in the street in front of the trailer for safety where it will be blocked from the flow of traffic. They will not block any sidewalk traffic other than customers in line to buy product. There will be a condiment table on the sidewalk for customer use.

They will be serving food and soft drinks. No alcohol will be provided.

REQUESTED COUNCIL ACTION

I respectfully request a motion approving permission for the Cannon Falls Lions to park and store their mobile food unit on Mill Street in front of Tilion Brewing the evening of October 4th; removing it on the evening of October 6th.

Proposal to Serve Food & Beverage at the Sogn Art Fair/Flavor of the Falls Event

The Cannon Falls Lions propose to park our trailer on Mill Street in front of Tillion's Brewery the evening of October 4th and remove it the evening of October 6th. We will require the space be reserved with cones that Friday the 4th in the afternoon. This is not a normal parking spot so it should not impede any of the day to day business parking needs. We will be setting up 2 propane grills and 1 propane heated pot to boil bratwurst. The grill and pot will be in the street in front of our trailer at the tongue position and for safety will be blocked from the flow of traffic by the trailer itself. This is to not block any sidewalk traffic other than people getting in line to buy product. There will be a condiment table on the side walk for our customers use.

We will either draw power from the city GFI outlets on the light pole to the left of Tillions front entry and/or the GFI outlet coming up from the ground at the tree to the right of Tillions front entry or provide our own generator if using the city outlets is not approved.

We will be serving food and soft drinks only no alcohol.

We will of course clean up after our selves though if a garbage receptacle can be placed at our location that would be appreciated.

We will have our permits in order to serve food to the public.
