BACKGROUND

The 2020 Presidential Nomination Primary election will be held on March 3, 2020. The City is required to appoint election judges that will be used for any election. The election judges will be selected from Exhibit A which is attached to the proposed resolution. Election judges must meet certain criteria in order to be eligible to serve. Staff will select from the list those that meet the requirements.

The Council will also be asked to approve wages for the election judges. Staff has reviewed the wages and are proposing to keep the wages the same from the 2018 elections.

REQUESTED COUNCIL ACTION

Staff respectfully requests the Council to adopt the resolution appointing election judges for the 2020 Presidential Nomination Primary election and approving the hourly wages for election judges.

**A RESOLUTION ADOPTING PRESIDENTIAL NOMINATION PRIMARY ELECTION
JUDGES FOR 2020 AND SETTING THE HOURLY WAGES**

WHEREAS, the City Council of the City of Cannon Falls is required by M.S. 204B.21, subd. 2, to officially approve the appointment of elections judges; and

WHEREAS, election judges must successfully complete training and eligibility requirements, and

WHEREAS, the Cannon Falls City Council hereby adopts the judges listed on Exhibit A, hereto attached, as the official judges for the March 3, 2020 Presidential Nomination Primary Election, with the understanding that substitutions may be necessary to the appointments in order to fill vacancies, and meet eligibility and party affiliation requirements; and

WHEREAS, the Cannon Falls City Council hereby sets the hourly wages as follows:

Head Judges	\$13.20
Election Judges	\$10.00

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Cannon Falls that the names listed on Exhibit A, hereto attached, are the official Election Judges for the City of Cannon Falls, for the March 3, 2020 Presidential Nomination Primary Election.

BE IT FURTHER RESOLVED, the City Council of the City of Cannon Falls, does hereby allow the Elections Administrator or City Administrator to make substitutions to the attached slate of judges as necessary to fill vacancies and to meet and maintain eligibility and party affiliation requirements.

BE IT ALSO FURTHER RESOLVED, the City Council of the City of Cannon Falls sets the hourly wages for the Head Judges to be \$13.20 and Election Judges to be \$10.00.
