BACKGROUND

Merit Contracting performed roof inspections on Archie Swenson Field concession stand, City Hall, Fire Hall, Library and Building 70 at the WWTP. Included in the inspection report is a quote for immediate repairs needed, and life extension repairs needed. Immediate repairs are deemed as necessary due to defects that are open, currently leaking, or are likely to leak in the next twelve months. Life extension repairs are those that would extend the life of the roof, defer capital, or are in monitor status. Archie Swenson needs \$574 in immediate repairs and \$7,730 in Life extension repairs. City Hall needs \$1,164 in immediate repairs and no life extension repairs. (City staff will be removing the debris and vegetation, so please disregard the \$210 repair.) Fire Hall needs \$687 in immediate repairs and \$6,479 in life extension repairs. Building 70 at the WWTP needs \$1,563 in immediate repairs and no life extension repairs. The Library needs \$1,635 in immediate repairs and no life extension repairs. *(The Library roof inspection report has been forwarded to Library Director Nicole Miller for consideration by the Library Board). Estimate for immediate repair of the 5 facilities is \$5,623. Estimate for life extension repair of Archie Swenson Concession Stand and Fire Hall totals \$14,209.

REQUESTED COUNCIL ACTION

Motion and approval to move forward with the immediate roof repairs needed at City Hall, Archie Swenson Ballfield Concession Stand, Fire Hall, and Building 70 at the WWTP facilities for a total of \$3,988. As stated above, the Library roof repairs would be approved by the Library Board.
