WHEREAS, the Cannon Falls Fire Department was provided with a cash donation for the purchase of equipment for the new 2020 Freightliner Pumper.

WHEREAS, at times opportunities arise to obtain equipment that is new or beneficial to the fire department that was not anticipated for within the yearly budget; and

WHEREAS, the CFFD Relief Association has donated \$3,240.74, to be used towards equipment for the 2020 freightliner pumper truck;

BE IT FURTHER RESOLVED, that the Fire Chief of the City of Cannon Falls is hereby authorized to be the fiscal agent and administer the donation on behalf of the Cannon Falls Fire Department.
