## **BACKGROUND**

Goodhue County has created a program from its American Rescue Plan Act (ARPA) funds designated toward broadband infrastructure in the county. With the impending water tower reconditioning project in 2022, the timing of applying for some funds from this program is quite timely. The project request in the application is to reinforce and expand the railing/ring on top of the water tower that accommodates the communication equipment that provides fixed wireless services to the surrounding area and Goodhue County currently houses their emergency communication equipment on the tower. The total project cost for the ring expansion is \$85,000. The application has been completed with an ask of \$42,500 from the county and a 50% match ask from the townships for \$42,500.

By expanding the railing, it will allow for additional tenants/providers to reside on the tower which will provide more coverage, options, speeds and pricing options for residents in and around the area reaching out into the six townships as well as Lake Byllesby area.

Each of the townships were contacted by Commissioner Anderson and Qualey fielded any questions the townships had regarding the matching funds, coverage area, etc. As of 12/16/21, not all of the townships had convened to formally discuss the topic, however, by the submission date for the application (January 3, 2022), a better estimate will have been collected to know what the participation match is. Vasa Township is the only one that has committed \$5000 toward the match, Cannon Falls Township has declined contributing funds. If the 50% match is unable to be met by the townships, the City of Cannon Falls will need to make up the difference for this part of the water tower reconditioning project expense or else the existing ring will continue to be utilized.

#### **Executive Summary:**

The expansion of the railing on the water tower in Cannon Falls will allow for broadband service providers to add fixed wireless communication equipment to expand the coverage capability in the area; primarily in the territory of the School District #252 for Cannon Falls.

The reason that we are concentrating on serving School District #252 is because it is a defined area which encompasses the townships of Leon, Cannon Falls, Warsaw, Stanton, Belle Creek and Vasa. The city of Cannon Falls is fortunate enough to have fiber-to-the-home within the city limits, but for those residents that live beyond that area, internet service is challenging. Due to the topography of the landscape in the Cannon River Valley area, the bluffs and valleys make line of sight (LOS) difficult for many residents living in the township areas. With the location of the Cannon Falls water tower standing 148 feet atop one of the higher points of the city, the height of it allows for tenants' communication signals to spread far and wide.

Currently, there are a couple fixed wireless providers residing on the water tower along with the Goodhue County Emergency Communication equipment. The City of Cannon Falls has a reconditioning project slated for the spring/summer of 2022 and the ring expansion will coincide with this project. It is an opportunity for the current tower tenants to upgrade their equipment, but it is also an opportunity to add additional tenants to expand more options for residents in the area for fixed wireless coverage, speeds and pricing availability.

Although this reconditioning project has been in the planning process for a few years, the most recent worldly events have proven how broadband and its availability and reliability are a necessity in today's everyday life. With students of all ages (Pre-K thru College) learning from home and adults working from home, there has been no better time than now to put this plan into motion to make a plea for its urgency to increase the expansion and availability to residents in our rural areas. Even those not working or learning, have been educated on the benefits of telehealth/medicine visits with their clinician and have continued to virtually visit with their practitioners even though in-person visits have resumed. The pandemic alongside the civil unrest occurring to the north of Cannon Falls, has prompted people from the densly populated metro areas and suburbs to drift outward toward smaller, rural areas to settle. These folks expect to have the quiet life, but the speed of light service they are accustomed to working from home. This is our opportunity to continue to attract people to our region and increase our population that will support our area business owners and schools.

As mentioned before, Goodhue County currently houses their emergency communication equipment on the water tower that serves the region. The City of Cannon Falls felt it was an opportunity to approach the County for assistance to reinforce or expand the ring so we can accommodate more broadband providers to the region and expand the services to the residents. In speaking with the Townships, the lack of service or unreliable service that is in their area is of great concern and this could definitely benefit many people and change their lives for the better.





Due to the topography of our region, the bluffs and valleys of the area make it very difficult for fiber to the home to become a reality for many residents in the rural areas. There are even people that live within a mile outside of the city limits that do not have

access to a direct connection to their home and rely on a satellite or wireless signal which is not always reliable or stable. This past year has definitely proven that students learning from home and parents or professionals working remotely have needed strong internet connection in order to conduct business or learn. Even those that may have not experienced instability or delays before experienced significant interruption to service when multiple users on multiple devices were utilizing service simultaneously. This project will allow more providers and also more equipment to reside on the watertower to increase the capacity available to those in the area.

Goodhue County Emergency Communication equipment has resided on the Cannon Falls water tower for many years free of charge. In order to allow for expanded broadband coverage to benefit the residents of the surrounding Cannon Falls area, it seems feasible that the County would allocate funds fom the Goodhue County Broadband Partnership Program to aid in reinforcing and expanding the ring to accommodate all of the necessary services for its residents in this part of the county.

They can not be coerced, but the value of adding additional broadband providers has been explained to each of them so they can bring it to their boards for discussion and vote.

The pandemic has people continuing to work remotely and some may never go back into an office setting again, so even though it may not be a business owner working remotely outside of Cannon Falls, that does not mean that there is not a lot of business conducted remotely in the rural areas of the Cannon River area.

The list would be too long as to the number of farms and ag customers that utilize internet. These days, most of the precision planting, drones and other ag related services all use broadband for mapping, planting, fertilizing and harvesting.

**7.3 Provide a listing of community institutions that will benefit from the broadband project.** There are a significant amount of churches and non profit organizations that have added a streaming option to the services they provide due to the past year. Many now offer church services or virtual coffee chats so people can remain connected but still safe in their home.

**7.4 Provide a listing of any educational locations that will benefit from the broadband project.** The Cannon Falls School District #252 and its students and faculty will be huge benefactors of this project. Cannon Falls does not have a higher education institution physically within it's borders, however there are many college students studying remotely earning their undergraduate degree as well as many grad students working on their Master's Degree from home. Learning occurs everywhere these days.

#### 7.5 Provide specific evidence of how health and public safety locations will benefit from the broadband

**project.** Telehealth is another industry that has seen a significant increase in the use of technology over the past 24 months. There are many clinics that offered virtual visits with patients and even mental health and addiction counselors were only offering virtual appointments for patients. Cannon Falls is fortunate to have the Mayo Clinic Health System in its community and the technology to support pivoting to this platform for its patience without missing a beat during the pandemic. This has now become part of their model and those that are home bound have become accustomed to 'tuning in' to meet with their doctor instead of having to line up a ride to get to the clinic instead. Having the capability to have access to quality internet is key for this platform to be successful.

**7.6 Is the proposed project providing broadband improvements to an economically distressed area?** This project will provide additional providers that each offer different service options that should suit the price and speeds at an affordable rate of their choice.

#### Goodhue County:

I write in support of the application by the City of Cannon Falls to allocate Broadband Partnership Program funds to enhance wireless broadband capacity on the Cannon Falls water tower. I live in Vasa Township, and while private industry has received some public funding to expand fiber networks in our area, some of us are stuck at the "end of the line" where it still may not make economic sense for companies to invest in burying cable along miles of corn fields just for one or two potential customers.

My nearest neighbor and I work from home, but are disadvantaged when our tasks require more bandwidth than our trusty old copper phone wires can handle. The last two years have accelerated the migration of the workforce from dedicated offices to the home. This disruption brings opportunity for small cities and rural areas, as white collar workers can now consider residing away from urban areas. However, areas without up-to-date broadband infrastructure will not be able to compete.

My property is divided between the Cannon Falls and Red Wing school districts. My daughter entered the school system this year. However, school is no longer limited to brick walls and paper take-home assignments. Again, the pandemic has shown us how productive and resilient our education system can be in the age of the internet. But while families with students within city limits tend to have state-of-the-art broadband options, there are huge drop-offs in rural areas of the county. As nostalgic as I am for the true snow days I once enjoyed as a kid, I also want my country girl to have the same opportunity to keep up and succeed in school as her peers.

I have engaged with all of the current fixed wireless offerings in my area. Vasa sits just below a hill crest from the east, and thus a preferred provider offering relatively fast speeds based from Red Wing does not quite have enough signal. Another provider specializing in rural areas has a somewhat reliable connection, but the speeds are no improvement over DSL. A third, coming from the west, is just barely out of range, but the speeds would not be great anyway. I have no doubt if Cannon Falls were able to provide water tower access to a reliable provider my prospects would be much improved.

Thank you for your consideration. I am grateful to Goodhue County for recognizing the vital role broadband increasingly plays in all aspects of our economy and daily life, and for allocating resources to address broadband access inequity. Goodhue County Park Board Members,

As you know, we are finalizing the design of the Pavilion at Byllesby Park.

That design includes security cameras and doors that we can open and close remotely.

We need to be able to communicate with those cameras and doors from Red Wing and that requires internet service of some sort. There is no fiber optic out there today and it would be expensive to dig in a line. The other option is to relay this service from an antenna. An internet provider, such as HBC, could provide this service if they can attach an antenna to Cannon Falls water tower.

The County has received Federal COVID Relief funds and supporting the expansion of internet is an eligible project for those funds.






