## RESOLUTION TERMINATING THE DEVELOPMENT AGREEMENT WITH GEORGE ON THE ROCKS, LLC AND DECERTIFYING TAX INCREMENT FINANCING DISTRICT NO. 2-7

WHEREAS, the City of Cannon Falls (the "City") has heretofore created Tax Increment Financing District No. 2-7 (the "TIF District"); and

WHEREAS, on December 1, 2017, the City and (the "Developer") entered into a Development Agreement (the "Agreement") in connection with the renovation of an existing substandard building and the acquisition, construction and equipping of an approximately 20,696 square foot local food and commercial center by the Developer (the "Project"); and

WHEREAS, the Developer desires to no longer receive any future tax increments derived from the Project, and has returned to the City all tax increments paid by the City to the Developer pursuant to the TIF Note (as defined in the Agreement).

NOW, THEREFORE, BE IT RESOLVED by the City Council (the "Council") of the City of Cannon Falls, Minnesota (the "City") as follows:

1. The City hereby terminates and cancels the Agreement and the Developer and the City shall be released from all of their respective duties, obligations and responsibilities under the Agreement as of the date hereof.

2. The City Council hereby finds, declares and determines to decertify the TIF District, effective as of the date of this resolution.

3. The City Administrator is hereby directed to send a copy of this resolution to the County Auditor of Goodhue County and the Office of the State Auditor and to take all other steps, if any, which are necessary to decertify the TIF District.

4. All tax increments collected from the TIF District that have been paid to the Developer and subsequently repaid to the City, together will additional unspent tax increments, shall be returned to the County Auditor of Goodhue County for distribution to the affected tax jurisdictions in accordance with Minnesota Statutes, Section 469.176, subdivision 2.
