BACKGROUND

Since the completion of the 2021 mill and overlay on Park Street West, an area of curb in front of 1000 Park Street West that pools water was brought to our attention. Also, the area around the catch basin on 6th Street North near the Mill Street Bridge has settled and is in need of repair. SFS Concrete submitted a quote of \$4,400 to repair these two areas. Public Works staff will assist as needed.
