BACKGROUND

The City of Cannon Falls held the City General Election on November 8, 2022 for the offices of Mayor, two 4-year Council Members and two 2-year Council Members. Minnesota State Statute requires the City Council to act as the Canvassing Board to canvass the returns and declare the election results. Goodhue County provides an Abstract of Votes Cast in the Precincts of the City of Cannon Falls compiling the results for the official returns. The results will be indicated in the proposed resolution. Once the results are adopted, the Council will sign the abstract as the Canvassing Board.

RECOMMENDED COUNCIL ACTION

Staff respectfully requests the Council approve the Resolution canvassing and declaring the election results and sign the Abstract of Votes Cast.
