## **BACKGROUND**

The public works staff use ferromagnetic metal detectors to locate buried infrastructure such as valves, manholes, and curb stops. This is an essential daily use tool for the water and wastewater operators.

Public works recently sent in for repair a Metrotech VM 880 Rx. The quote to repair the unit came to \$725.00. Looking into the history of the metal detector it is about 5 years old and has been sent in for repairs at least 3 times. The cost of a new identical metal detector is \$1,185.00.

Public works would like to replace the metal detector with a Schonstedt brand locator with the price ranging from \$950.00 to \$1,075.00
