In 2023 the Cannon Falls Pool had three areas in need of repair. The Public works requested a quote from The Caulkers Co. and It was decided then to repair one area per year to divide up the cost.

The Caulkers Co. provided an updated quote to repair the splash pad area.

With in the splash pad all existing caulked joints, the 2 splash area perimeter joints and center expansion joint and the surrounding concrete deck joints, cut out the existing sealants, grind masonry edges, clean out and prep all joints to be caulked, install new backer rod where needed and required and install Master Seal SL2 Sealant and tool to a level and professional finish.

Total cost to caulk the splash pad area- \$4,290.00.
