BACKGROUND

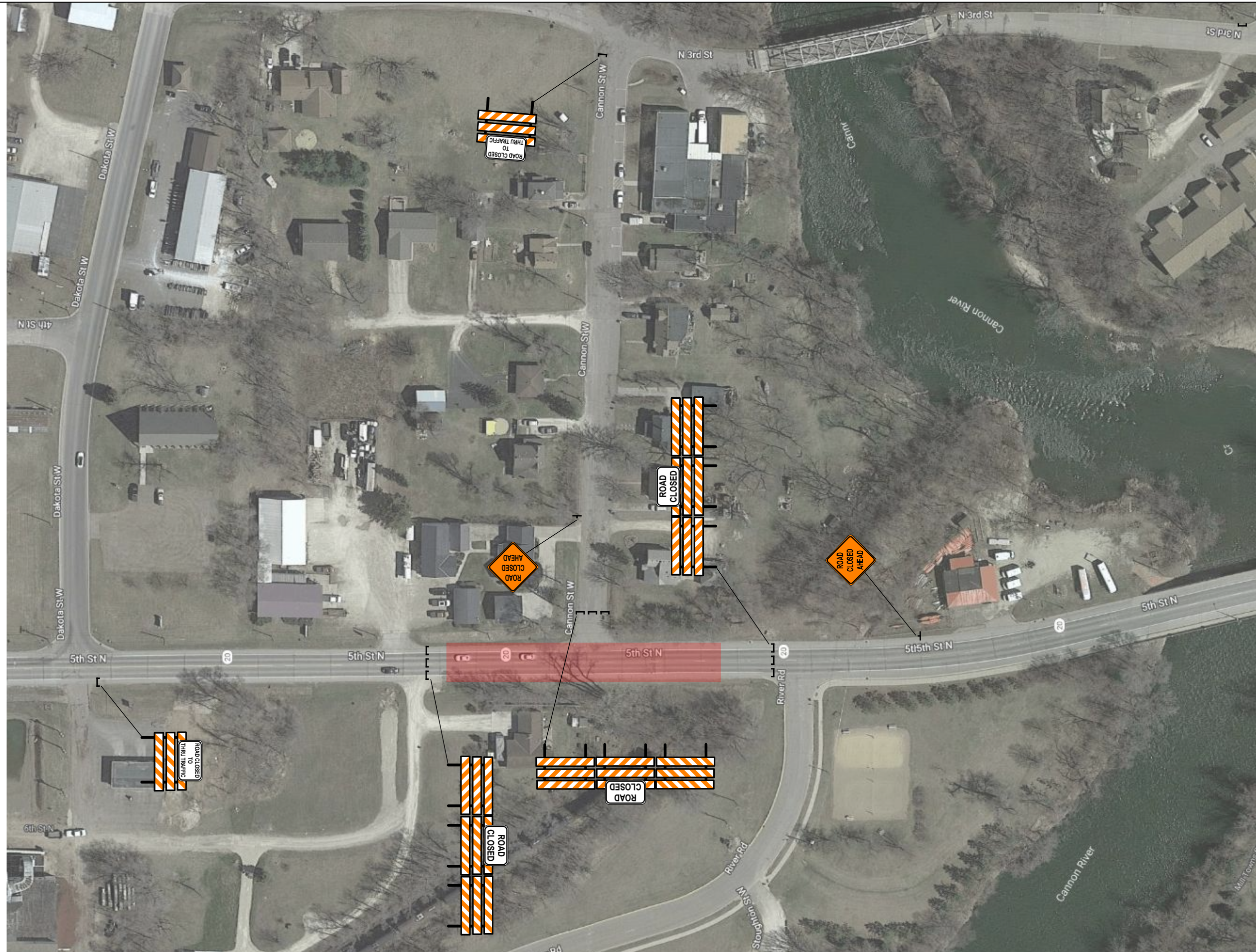
Fitzgerald Excavating & Trucking the general contractor for the 2023-2024 street reconstruct project needs to close State Rd 20 at the intersection of Cannon St on April 22, 2024.

MNDOT has approved the following detour and traffic control plan (see attached). Safety Signs will provide the signage and set up traffic control. Traffic would be detoured at Mill St across the bridge to Stoughton St then past the pool and fairgrounds, to County Rd 17, and back to State Rd 20. The detour is expected to last one day but if complications arise could be extended a second day. Advanced warning signs will be installed on April 15th.

This could possibly have a significant impact on traffic traveling through town on April 22, 2024.

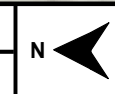

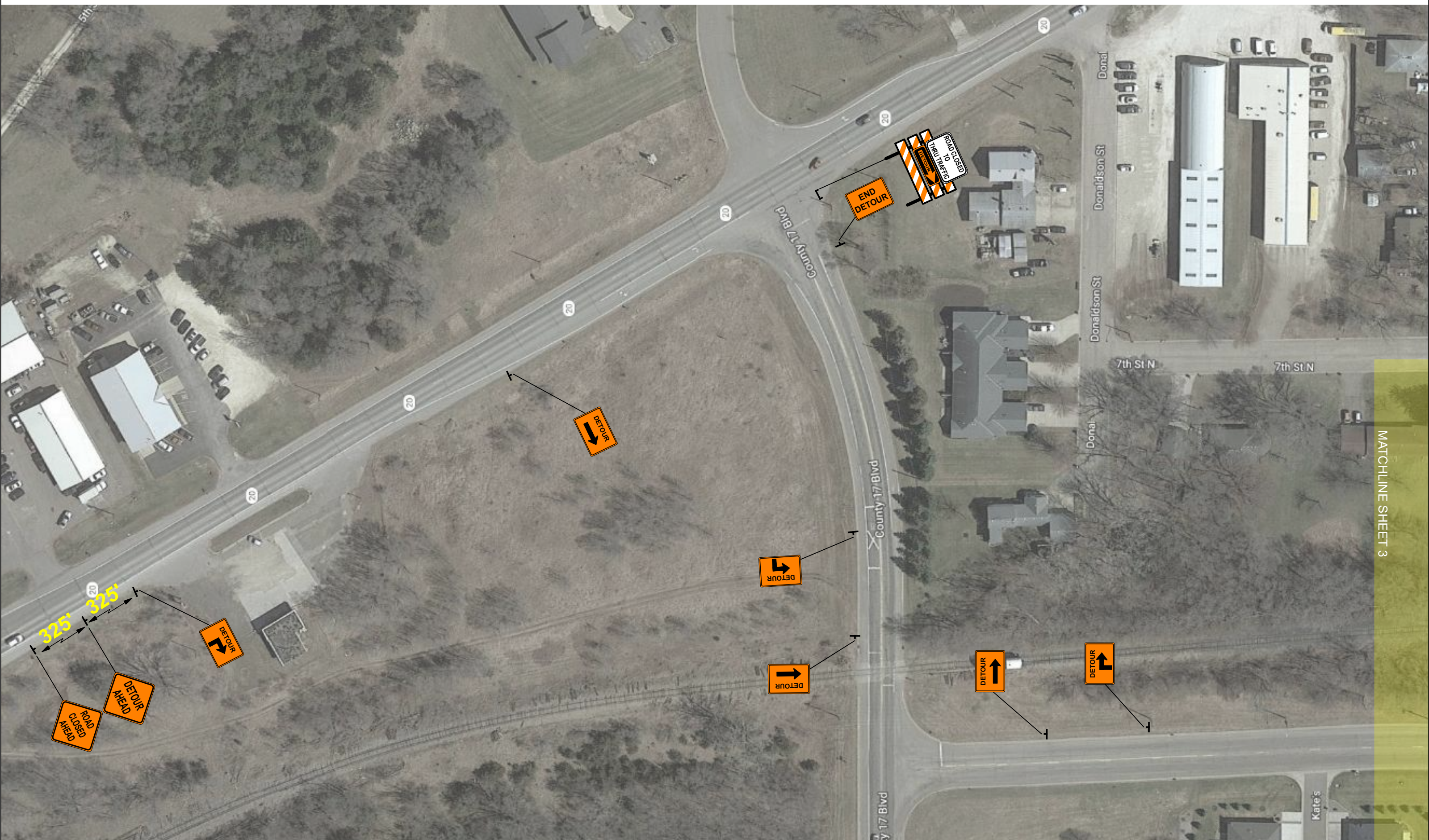

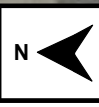
