**SUBJECT: ELECTION JUDGES FOR 2024 PRIMARY AND GENERAL ELECTIONS**

**BACKGROUND**

The 2024 Primary and General elections will be held on August 13, 2024 and November 5, 2024. The City is required to appoint election judges that will be used for any election. The election judges will be selected from Exhibit A which is attached to the proposed resolution. Election judges must meet certain criteria in order to be eligible to serve. Staff will select from the list those that meet the requirements.

The Council is also be asked to approve wages for the election judges. Staff has reviewed the wages and the wages are comparable to other cities within the County.

**REQUESTED COUNCIL ACTION**

Staff respectfully requests the Council to adopt the resolution appointing election judges for the 2024 Primary and General elections and approving the hourly wages for election judges.

**A RESOLUTION ADOPTING PRIMARY AND GENERAL ELECTION JUDGES FOR  
2024 AND SETTING THE HOURLY WAGES**

**WHEREAS**, the City Council of the City of Cannon Falls is required by M.S. 204B.21, subd. 2, to officially approve the appointment of elections judges; and

**WHEREAS**, election judges must successfully complete training and eligibility requirements, and

**WHEREAS**, the Cannon Falls City Council hereby adopts the judges listed on Exhibit A, hereto attached, as the official judges for the August 13, 2024 Primary Election and the November 5, 2024 General Election, with the understanding that substitutions may be necessary to the appointments in order to fill vacancies, and meet eligibility and party affiliation requirements; and

**WHEREAS**, the Cannon Falls City Council hereby sets the hourly wages as follows:

Election Judges      \$15.00

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Cannon Falls that the names listed on Exhibit A, hereto attached, are the official Election Judges for the City of Cannon Falls, for the August 13, 2024 Primary Election and the November 5, 2024 General Election.

**BE IT FURTHER RESOLVED**, the City Council of the City of Cannon Falls, does hereby allow the Elections Administrator or City Clerk to make substitutions to the attached slate of judges as necessary to fill vacancies and to meet and maintain eligibility and party affiliation requirements.

**BE IT ALSO FURTHER RESOLVED**, the City Council of the City of Cannon Falls sets the hourly wages for the Election Judges to be \$15.00.
