Background:

The Cannon Falls Fire Department and EMS currently rely on aging and obsolete handheld radio equipment that is increasingly difficult to maintain and no longer meets the demands of modern emergency response. Upgrading our communications infrastructure is critical to ensure the safety of both our first responders and the residents they serve.

The Assistance to Firefighters Grant program offers an opportunity to secure federal funding from FEMA for essential firefighting and emergency response equipment. The grant requires a local match of 5%, which would need to be covered by the Cannon Falls Fire Department and EMS budgets.

Financial Implications:

The total estimated cost for the new radios is approximately \$331,245. If awarded the grant, FEMA would cover 95% of this cost, amounting to \$314,683. The City's 5% match would be \$16,562 (\$11,041 CFFD; \$5,521 EMS), which could be allocated from budgeted equipment funds or donations received. The CFFD/EMS did receive \$50,000 from the Department of Public Safety for new encrypted radios for the apparatus' earlier in 2024.

Recommendation:

Staff recommends that the City Council approve this request to apply for the AFG grant. The application deadline is December 20th, 2024, and timely approval is necessary to ensure submission. If awarded, this grant will significantly enhance the capabilities of our Fire Department and EMS while minimizing the financial burden on the City.

Action Requested:

 Approve the request to apply for the Assistance to Firefighters Grant.
Authorize Laura Qualey, Community & Business Development Specialist to complete and submit the grant application on behalf of the Cannon Falls Fire Department and EMS.
