# **BACKGROUND**

Historically, we have replaced an ambulance every three years. This rotation ensures that our oldest ambulance is nine years old at the time of replacement. We have found that after nine years, maintenance costs increase dramatically each year we continue to keep the unit in service.

To maintain reliable service, we have traditionally purchased new ambulances, which come with warranties and help minimize downtime. However, the cost and lead times for new ambulances have significantly increased. Currently, the lead time for new ambulances range from 900 to 1,200 days.

In light of these challenges, MacQueen Emergency Group has submitted a proposal for remounting an existing ambulance. MacQueen is located in St. Paul, making it convenient for any follow-up service or warranty work after the remount is completed.

Remounting offers a cost-effective alternative while still ensuring reliability, quicker turnaround, and continued service life for our fleet.

### REQUESTED COUNCIL ACTION

Motion to approve the ambulance remount project with MacQueen Emergency Group for a price not to exceed \$213,000.00 at today's cost. Pricing is based on a competitive bid process through Sourcewell, a national cooperative purchasing program. Authorize the EMS Chief to execute all necessary paperwork related to the ambulance remount process.
