BACKGROUND

The St. Pius V Catholic Church is seeking approval of a permit application to conduct lawful gambling activities on February 7th, 2026, at 410 Colvill Street West, Cannon Falls. The state requires City Council approval of gambling premises within city limits.

RECOMMENDED COUNCIL ACTION

Motion and approval of the state application for Gambling Premises Permit for the St. Pius V Catholic Church at 410 Colvill Street West.

MINNESOTA LAWFUL GAMBLING
LG220 Application for Exempt Permit

An exempt permit may be issued to a nonprofit organization that:

- conducts lawful gambling on five or fewer days, and
- awards less than \$50,000 in prizes during a calendar year.

If total raffle prize value for the calendar year will be \$1,500 or less, contact the Licensing Specialist assigned to your county by calling 651-539-1900.

Application Fee (non-refundable)
Applications are processed in the order received. If the application is postmarked or received 30 days or more before the event, the application fee is **\$100**; otherwise the fee is **\$150**.
Due to the high volume of exempt applications, payment of additional fees prior to 30 days before your event will not expedite service, nor are telephone requests for expedited service accepted.
